It took 67 days but I'm delighted to say that this morning I got my official response from the Information Commissioner's Office Case Team. My specific question was: "please answer 'yes/no' to whether legitimate interests may be appropriate to send marketing emails to employees at a corporate body to their personal corporate email addresses (e.g., personsname@org.co.uk) in situations where soft-opt in doesn't apply (e.g. where the person is not an existing customer)." ICO's response is: "If you are sending a marketing email to a corporate subscriber such as, firstname.lastname@company.com, then you do not need prior consent before you send the marketing email...You may be able to rely on legitimate interests to justify some of your business to business marketing". The B2B marketing elephant has definitely left the building! #b2bmarketing #PECR #gdpr #legitimateinterests



The email WorkFlow


